Anemia has been a serious public health issue in our country since many years. One in two under five children, adolescent girls and women including pregnant women and lactating mothers are anemic. Taking cognizance of this, Government of India developed "Anemia Mukt Bharat' (AMB) strategy in adherence to the POSHAN Abhiyan with the target beneficiaries through the life cycle approach.

One of the important aspect of the program is to conduct strong monitoring and supervision of the program, for which following HMIS indicators need to be monitored regularly:
