Subject: Webinar for RPA/PA Nutrition, Nutritionist and Nutrition Assistant (NHM funded CMTC-NRC) regarding Management of Children with SAM at CMTC-NRC during COVID 19 and NDD August'20 round.

The Government of Gujarat is Committed towards malnutrition free mother and children of State. As per the World Health Organization, Children with severe acute malnutrition (SAM) are nine times at high risk of getting any type of infections compared to others. In the last decade, severe acute malnutrition has increased from 5.8 per cent (NFHS-3,2005-06) to 9.5 per cent (NFHS-4,2015-16) in Gujarat. The Comprehensive National Nutrition Survey of (2016-17) showed the prevalence of SAM to be 6.9% in Gujarat.

As we all are aware that every year NDD round os celebrated biannually this year also will be conducting NDD round from 10th to 17th August'20. National Deworming Day (NDD) program is celebrated with the objective to deworm all preschool and school-age children (enrolled and non-enrolled) between the ages of 1-19 years through the platform of schools and Anganwadi Centers.

Management of such children at CMTC-NRC is an utmost priority especially during COVID 19 Pandemic Also It is necessary to take up strategic plan for NDD round for August'20 round & Covid-19 pandemic to strengthen program & prevent transmission by following the protocols of Covid-19 as per the released guidelines. In regards to this, a webinar is going to be host by Department of Health and Family Welfare, Gujarat in coordination with UNICEF, Gujarat from State level for an orientation of RPA Nutrition, PA Nutrition, Nutritionist and Nutrition Assistant of NHM funded CMTCs-NRCs.
