Sub: Distribution of IFA with mid day meal ration for students during COVID-19 situation.

Sir,

With reference to the subject cited above this is to inform you that the Weekly Iron Folic Acid Supplementation is an inimitable programme of GoI to prevent anaemia. Regular IFA supplementation is very essential for health and cognitive development of all children. In general NHM, Assam supplies IFA tables to schools and/or nearest Sub Centres for collection of IFA tablets by schools and the platform of school is used for supplementation of IFA to students from class I to XII. Due to the untoward situation owing COVID 19, IFA supplementation for all school going children is not taking place since April, 2020. Anticipating that all schools have sufficient stock of IFA tablets or in case of shortage school has the option to get it from nearest Sub Centre to continue supplementation, you are kindly requested to facilitate the distribution of IFA tablets along with Mid Meal ration to all students upto class VIII. Your support will be highly appreciated during this over-wrought episode of Health department. Details on supplementation process are enclosed for reference.

#### Guidance note

Iron deficiency during childhood is often caused by inadequate dietary intake, absorption or utilization of iron, increased iron requirements during the growth period, or blood loss due to parasitic infections such as malaria and soil-transmitted worm infestations. Adolescents (age 10–19 years) are at high risk of iron deficiency and anaemia due to accelerated increase in requirements for iron, poor dietary intake of iron, high rate of infection and worm infestation as well as the social norm of early marriage and adolescent pregnancy. During this stage the requirement of nutrition and micronutrients is relatively high. Therefore, adolescents, especially girls, particularly those between the ages of 12–15 years, are vulnerable to iron deficiency mainly because requirements are at a peak. Evidence from many countries across the globe suggests that a weekly IFA supplement is as efficacious as daily supplements with a much lower rate of side effects.

The Weekly Iron Folic Acid Supplementation programme is for boys and girls in school (5–19 years) and out of school girls (5–19 years) in urban and rural areas and will be implemented through the platform of Government/Government aided/ municipal schools and AWCs. The strategy involves a "fixed day – Monday" approach for IFA distribution. Teachers and AWWs will supervise the ingestion of the IFA tablet by the beneficiaries.

### Prophylactic dose and regime for Iron Folic Acid supplementation

Age Group	Class	<b>Tablet Colour</b>	Dose and regime	
Children 5–9 years of age	I to V	Pink	Weekly, 1 Iron and Folic Acid tablet Each tablet containing 45 mg elemental Iron + 400 mcg Folic Acid	
Children 10–19 years of age	Vi to XII	Blue	Weekly, 1 Iron and Folic Acid tablet Each tablet containing 60 mg elemental iron + 500 mcg Folic Acid.	

<sup>\*</sup>Prophylaxis with iron should be withheld in case of acute illness.
