Sub: Preparatory activities for upcoming "National Deworming Day" (NDD) round scheduled to be held in September 2020

Ref: DFW letter No. 627 Dt.29.6.2020, WCD&MS letter no.9301 Dt.25.08.2020, MoH&FW letter no. Z-28020/99/2020-CH Dt. 17.07.2020

Madam/Sir,

The NDD programme aims to provide age appropriate dose to Albendazole (suspension/tablet) to the children from 1 to 19 years of age through the school and AWC platform. However, due to COVID-19 pandemic the schools are unlikely to reopen before November 2020 and AWCs are also closed till 30th September 2020. In this light it has been decided to adopt the alternative suggested by MoH&FW, GoI (as per the reference letter) i.e. in case the schools and AWCs are closed beyond 31st August 2020 the state may identify alternate platform for service delivery through door to door approach by the frontline functionaries (AWW, ASHA &ANM), who are delivering other essential and nutrition services at the doorstep and the state may conduct the round over a week for achieving optimum coverage. Therefore, in our state NDD programme shall be implemented from 21.09.2020 to 26.09.2020 by adopting the alternate platform as suggested by MoH&FW,GoI.

For successful implementation of a programme all the districts are requested to kindly plan the following important activities in advance for the successful implementation of NDD round:

- 1. Target setting: The districts to be covered under NDD should prepare the microplan for the district based on the age group mentioned above in coherence to census population and share the same with the state.
- 2. **Availability of drugs:** Based on the current stock status of Albendazole tablet and suspension at district and block level, the district needs to assess their requirement for the upcoming round based on the age group mentioned above and prepare the distribution plan accordingly.
- 3. **District level Committee Meeting:** This meeting is to be organized by all districts prior to commencement of NDD September 2020 round. Please confirm the participation of Department of Education, Department of WCD, Department of Drinking water and Sanitation, Department of Tribal Welfare, Department of Panchayati Raj, Swachh bharat Mission, NVBDCP, Private school association as critical stakeholders to the planning and implementation of the NDD program.

Hence, you are requested to kindly take up the preparatory activities for your district for smooth implementation of the programme.
