Sub:-Distribution of Food Security Allowance (MDM) during COVID-19 lockdown.

Madam/Sir.

I am directed to invite reference to Letter No. 10276/SME, dt. 24.07.2020 of S&ME Department on the above subject and to say that Government have been pleased to allow distribution of Food Security Allowance under Mid Day Meal programme (both dry rice and cooking cost) during COVID-19 lockdown to the eligible students as per MDM Rules for 57 school working days at one go in the 2nd phase from 14.06.2020 to 31.08.2020 with the following modalities;

- i. Dry ration (rice) shall be provided for 57 days at school point by Headmaster in presence of SMC out of available MDM rice in schools.
- ii. In case of schools having MDM rice for more than 57 days, the CRCC should re-allocate the excess rice and divert the same to the nearby schools having deficit MDM rice maintaining proper accounts in both the schools under intimation to the DEOs & BEOs.
- iii. Even after such adjustment by CRCC if there is still shortfall, coupons for balance quantity to be issued to parent/ guardian to enable them to receive the dry ration from previously tagged FPS/ PDS outlets.
- iv. Payment of cooking cost for the 57 days should be made directly to the account of school students/ parents/ guardian on DBT mode.
- v. If Quarantine Centre or Temporary Medical Camp or Covid Care Home has been vacated and the school building is no longer used as such the building shall be sanitized and handed over back to the Headmaster. After such sanitization, the premises can be used as a distribution centre of Food Security Allowance (MDM dry rice).

- vi. If Quarantine Centre/ Temporary Medical Camp/ Covid Care Home is in operation in the school premises, but the school authorities and SMC have access to the Headmaster's chamber and store room of MDM rice, arrangements should be made to take away the MDM rice to the nearly school or community centre and use the same as Food Security Allowance (MDM rice) distribution centre. The transportation of rice from the school used as quarantine centre to the nearby school or Community Centre can be done by the Cook-cum-Helper or the local SHG (if tagged to that school) or by local labourer. The transporting cost at the local prevalent rate can be met from the sales proceeds of the gunny bags or the interest money available in the school or with District Education Officer.
- vii. If Quarantine Centre/ Temporary Medical Camp/ Covid Care Home is in operation and the rice stored therein cannot be removed and taken to other places because of accommodation of positive inmates or other contingent circumstances, then the fact may be intimated to Collector through DEO.
- viii. The Headmaster is usually In-charge officer of the Quarantine Centre/ Temporary Medical Camp/ Covid Care Home running in a school. Hence, the Headmaster can explore the option of handing over the MDM rice at the economic cost of Rs. 32/- per kg (FS&CW Deptt) to the food supplier or cooking agency for that quarantine centre. The same cost shall be deposited with DEO.
- ix. All COVID 19 safety norms like face masking, hand sanitizing, social distancing etc. shall be strictly adhered to during the transportation and dry ration rice distribution.
- x. The SMC shall be kept informed while distributing the coupons and MDM rice at FPS/ PDS outlets.

You are therefore requested to please take immediate appropriate action to reach the Mid Day Meal entitlement to the children (Food Security Allowance) under intimation to this Department.
